Background

- In 2012 -2013 Build Up Skills Pillar I project was carried out providing Status Quo Analysis identifying the major obstacles in developing competences of craftsmen and onsite workers in the sector of buildings;
- Entrepreneurs and the Government negotiated a Roadmap to overcome obstacles and set up qualification and education scheme and motivate investments in competencies (skills and knowledge) relevant to energy efficiency and use of renewable energy sources in buildings;
- Government drafted a strategy based on the Roadmap and committed itself to its implementation.
